# Secretary's report

# Membership Dues

There is some concern that previous members of SLABA will have to pay more dues to join the NWLA with the registration fee of \$40.00 and \$35.00 yearly dues, totaling \$75.00. We discussed waiving the registration fee for people who were SLABA members.

# <u>Bylaws</u>

We need to clarify the language in the Bylaws pertaining to being an active member of NWLA. Cattle must be registered with ALR and members reside in the region. We also need to change the Bylaws to be more clear about raising the dues to the flat rate of \$35.00 and eliminating the per animal fee. This should also be clearly stated in the letter sent out to Lowline owners.

## EXPO 2013

The date has been set to May 3-5. It will be held at Idaho Lowlines again. There will be a wine tasting fundraiser, Private Treaty Sale, and a Jackpot Futurity. There will be more demonstrations and seminars as well as a lot of kids' activities. Diana says that local winery, Coeur d' Alene Cellars might be interested in participating in the wine tasting.
