AAA Promotion Committee minutes provided by Shelly Dodd

- Last year's focus was getting assets and getting Dean to 4 trade shows. Agtown started out with 0 promotion assets. It's a work in progress but now they have photos, interviews, videos. Always working on more.
- Agtown is planning what trade shows Dean should go to. Options below:

 - o Idaho Cattle Assoc
- The goal eventually will be to host trade shows with financial help from AAA. Also trying to get speaking engagements at some of the trade shows.
- There is a proposal to do a RFD-TV segment
 - Full segment 15k plus travel/expenses to film or 13k if footage provided. 18-22 minutes of content.
 - Half segment 8k plus travel/expenses to film or 6-7k if footage provided.

 - Focus will be on commercial cowman and smaller grass-fed operations.
